

## SAMPLE WILL

I, Hunter T. Sompson, residing at 910 Harrison Ave, Los Angeles, CA declare this to be my Will, and I revoke any and all wills and codicils I previously made.

### ARTICLE I: Administration

I direct my Personal Representative to pay out of my residuary estate all of the expenses of my last illness, administration expenses, all legally enforceable creditor claims, all Federal estate taxes, state inheritance taxes, and all other governmental charges imposed by reason of my death without seeking reimbursement from or charging any person for any part of the taxes and charges paid, and if necessary, reasonable funeral expenses, including the cost of any suitable marker for my grave, without the necessity of an order of court approving said expenses.

### ARTICLE II: Money, Personal Property & Digital Assets

I devise, bequeath, and give my copyright in “Moto X” feature film and all related video and media assets that went into making Moto X to my friend, James Smith.

I devise, bequeath, and give my copyright in “Desert Scenes” short film and all related video and media assets that went into making Desert Scenes to my brother, Bill Sompson.

I devise, bequeath, and give my cameras, and all camera equipment to my sister, Samantha Jones.

I devise, bequeath, and give my Harley Davidson motorcycle to my son, Sam Sompson.

I devise, bequeath, and give all my digital assets and real estate and all policies and proceeds of insurance covering such property and all the rest and remainder of my residuary estate to my current wife at time of death. Digital assets means all media I have rights in and all media I have partial rights in that I have not devised and bequeathed to others in this last will and testament. If I have no wife at time of death, I give my digital assets and real estate and remainder of my residuary estate to those of my children who survive me, in equal shares, to be divided among them and the descendants of a deceased child of mine, to take their ancestor's share per stirpes. Division of assets to my children will be by my executors in their absolute discretion after consultation with my children. My executors may pay out of my estate the expenses of delivering tangible personal property to beneficiaries.

### ARTICLE V: Taxes

I direct my executors, without apportionment against any beneficiary or other person, to pay all estate, inheritance and succession taxes (including any interest and penalties thereon) payable by reason of my death.

ARTICLE VI: Minors

If under this will any property shall be payable outright to a person who is a minor, my executors may, without court approval, pay all or part of such property to a parent or guardian of that minor, to a custodian under the Uniform Transfers to Minors act, or may defer payment of such property until the minor reaches the age of majority, as defined by his or her state of residence.

ARTICLE VII: Fiduciaries

I appoint my wife at time of death as Executor of this will. If she is unable or unwilling to act, or resigns, I appoint my daughter, Jenny Sompson, and my son, Sam Sompson, as successor co-executors. If either co-executor also predeceases me or is unable or unwilling to act, the survivor shall serve as executor. My executor shall have all the powers allowable to executors under the laws of this state. I direct that no bond or security of any kind shall be required of any executor.

ARTICLE VIII: Simultaneous Death Clause

If my spouse and I shall die under circumstances that the order of our deaths cannot be readily ascertained, my spouse shall be deemed to have predeceased me. No person, other than my spouse, shall be deemed to have survived me if such person dies within 30 days after my death.

ARTICLE IX: Guardian

If my wife does not survive me and I leave minor children surviving me, I appoint as guardian of the person and property of my minor children my brother Bill Sompson. He shall have custody of my minor children, and shall serve without bond. If he does not qualify or for any reason ceases to serve as guardian, I appoint as successor guardian my cousin Kevin Moon.
